The other conditions are:

2) Term

The term of all the members shall be three years.

3) Meeting

- The Board of studies shall meet as often as may be necessary but not less than two times during the academic year.
- A notice of at least 7 days shall be given for a meeting of the Board of studies along with the agenda prepared with the approval of the Chairman, Board of Studies.
- Every meeting shall be presided over by the Chairman of the Board of Studies.
- Convener shall finalize the Minutes of the proceedings as soon as possible after the meeting.
- Decisions at the meeting shall be taken by a simple majority and shall come into force only on the approval by the Academic Council . However the proposals shall be recommended by the Director to the Academic Council.

4) Functions, Roles and Responsibilities

The Board of Studies under the overall supervision of Academic council, GBU shall:

- Recommend the course syllabi, course structures and evaluation schemes of various courses keeping in view the objectives of the University, interest of the stakeholders and national requirement, for consideration and approval of the Academic Council;
- Recommended the reference books, supplementary reading books, ICT tools for academics and such other material useful for study of the courses;
- Recommend modifications in respect of addition or deletion or updating of courses;
- Prepare the requirements with regard to library, laboratory, equipment in respect of courses concerned.

- Suggest extension programmes with respect to the courses introduced.
- Understand the requirements of industry or corporate or society at large and to incorporate them into the syllabi to make the teaching-learning process relevant to the needs of the time;
- Encourage learning by collaboration and participation by using information and communication technology tools;
- Submit List of faculties to be recognised as PhD supervisors to the Academic Council for approval.
- Advise on all matters relating to their respective subjects referred to them by authorities of GBU.
- Any other academic matter referred to the Board of Studies.
