## **Eligibility Criteria for the Bidder**

- 1.** The bidder should have a total sum of turnover **₹ 1 Crore** in the **last three financial years** and the turnover of the **last year should be at least ₹ 30 Lakhs**. The Certificate certified by Chartered Accountant mentioning turnover of last 3 years should be attached along with the bid **(Form no. F-1)**.
- 2.** Bidders who wish to participate in this bid will have to visit on **<https://www.nprocure.com> and <https://www.gbu.nprocuer.com>** Further bidders who wish to participate in online bids will have to procure Digital certificate as per Information Technology Act 2000 using which they can sign their electronic bids.
- 3.** No conditional tenders shall be accepted and such tenders shall be treated as rejected.
- 4.** Physical submission of price bid will not be considered and such tenders shall be treated as rejected.

## The terms and conditions

1. The last date of submission of bid on website <https://www.nprocure.com> or <http://www.gbu.nprocure.com> **19/05/2022 till 6 PM**. No physical (Commercial) bids will be accepted under normal circumstances. However, GBU reserves the right to ask the bidders to submit the bid and /or any other documents in physical form.
2. The bid is non-transferable.
3. The bidder has to submit the **compliance letter** on its letter head duly signed by the authorized signature and other supporting documents as asked for in the bid in scanned format. Failing to submit the same or non-compliance/deviation from any bid terms and conditions, eligibility criteria or technical specifications may result in rejection of its bid (**Form no. F-2**).
4. The bidder shall bear all the costs associated with the preparation and the submission of its bid, and GBU in no case will be responsible or liable for these costs, regardless of conduct or outcome of bidding process.
5. The Bidder has to examine all instructions, forms, terms, conditions and specifications in the bidding documents. Failure to furnish all information required by the bidding document or submission of a bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of its bid.
6. The Bidder will have to submit **Non-refundable Tender Fees of as per Table-1 and Earnest Money Deposit (EMD)**, on or before the date and hours of opening of the bids in a sealed cover at GBU office with the heading "**Tender fees and EMD for the E-tender no. GBU/RC/04/2022/1 for rate contract of laboratory consumables, chemicals, glassware**". Tender fees and E.M.D (refundable) must be in the form of Demand Draft in the name of "**Gujarat Biotechnology University**" payable at Gandhinagar along with the covering letter. Please affix stamp of your company on the overleaf of demand draft. **The amount of EMD shall be as mentioned in Table-1 as per the category**. The details of EMD and Tender Fees are to be submitted (**Form-F3**).
7. The successful tenderer shall have to furnish Security Deposit in the form of Demand Draft in the name of "**Gujarat Biotechnology University**" payable at Gandhinagar. **The same will be returned to the supplier after 90 working days after the completion of tenure of rate contract. The Supplier shall not be entitled to any interest for the said deposit for same period. The Security deposit shall be as on award of letter of intent/work order and security deposit applicable as per 5% of estimated value order.**
8. Unsuccessful bidder's E.M.D. will be returned as promptly as possible as but not later than 15 working days after the expiration of the period of bid validity OR upon the successful Bidder signing the Contract, and furnishing the Security Deposit whichever is earlier. If you fail to provide Security Deposit, such failure will constitute breach of contract and GBU shall be entitled to forfeit EMD.

9. In case of non-receipt of Tender fees and EMD as mentioned above within prescribed time the bid will be rejected by GBU as non-responsive.
10. EMD and Security deposit for each category must be submitted separately and bidder shall submit the details regarding EMD for respective category.
11. The tenderers will have to indicate the brand of the product for which they are submitting their rate contract offer.
12. GBU is interested to enter into annual rate contract with only reputed manufacturers or with their authorized dealers/distributors. Hence the tenderers are advised to attach the relevant documents along with their offer to prove credentials or bonafides with regard to their well-established manufacturer or authorized dealer in terms of quality/reputation of their products in scientific community **(Form no. F-4)**.
13. The latest copies of Income Tax Return, CST, BST Registration must be submitted along with your offer **(Form no. F-5)**.
14. Please do submit the list of your customers (Government/Private research Laboratories/Institutes of repute with special reference to CSIR/DBT/ICMR laboratories/institutes.). In your customer list the name of the contact person, designation, telephone, fax and e-mail numbers must be given **(Form no. F-6)**. Five copies of the order each from reputed institution is to be submitted **(Form no. F-7)**.
15. This office shall prefer to enter into rate contract with manufacturers who can supply the materials directly to GBU laboratories from depot or warehouse in Gujarat. **This is to enable the supplier to execute the orders of GBU within 24 hours.**
16. Please mention maximum discount on your price list as applicable to Government Research/Educational Institutes. Discount must be indicated in words as well as in figures for each category and brand **(Form F-8)**. **Submit price bid online only as per Physical submission will lead rejection of the bid.**
17. All the bidders must submit their stamped price list from manufacturer or company with EMD and Tender fee in separate cover. Price list and catalogue in soft copy is preferable.
18. The Rate Contract must be valid for a period of **one year** from the date of awarding contract and it may be renewed on expiry at the sole discretion of GBU on the terms and conditions subject to the satisfactory performance of the tendered.
19. After expiry of tender/contract, bidder must supply the items at the same rate, terms and conditions of the tender maximum up to six months or till the completion of empanelment of new agencies, whichever is earlier.
20. Prices shall be exclusive of duties and taxes. The prices shall strictly be submitted in given format **Online only**. Taxes and Duties as applicable shall be mentioned separately in the respective columns.
21. The order will be given to the bidder submitting lowest price (L1) of the item in the relevant category in the pricelist submitted at the time of empanelment. In case of issues such as poor quality,

incompatibility, unsatisfactory service order shall be given to L2 or the next qualifying party.

22. Payment will be made within **45 days** after the receipt of equipment in our stores in good condition, successful installation and operational training. No other payment term will be acceptable to us. Payment will be made directly to the suppliers by crossed Cheque.
23. The manufacturers must indicate names and addresses of their local authorized dealers.
24. The offer/ prices/ stores should be free delivery at GBU, Gandhinagar inclusive of packing [4 °C, -20 °C, Dry ice or any other specific packing conditions required] and inclusive of all freight, forwarding, and transit insurance. This office shall not pay any additional charges. Date & Duration of Delivery: **within 21 days from** the receipt of purchase order.
25. The Date & Duration of delivery should be strictly adhered to, otherwise the **Competent Authority, GBU** reserves right not to accept the delivery in part or full and to claim the liquidated damages 2% per week subject to maximum 10% of total value of the order. In case of delay of over Five weeks in completion of the delivery beyond the stipulated delivery date, GBU reserves the right to forfeit security deposit and blacklist party at any time.
26. The tenderer must agree for immediate free replacement in case of any discrepancy is found with regard to quality/quantity of the material supplied by them under this rate contract and such items should be replaced within 7 days after communication from this office or otherwise it shall be considered as delayed delivery and this office shall claim liquidated damages 2% per week subject to maximum 10% of total value of the order.
27. In case of any sum of money is recoverable from and payable by the supplier, this office shall recover such sum by appropriating in part of whole from total value of the order and from the security deposit.
28. The bidder is required to furnish the Permanent Account Number (PAN) as allotted by the Income Tax department.
29. Wherever applicable and also in case of minor equipments, minimum comprehensive warranty should be of three years.
30. The price to be quoted (price as indicated in the price list less discount, excluding taxes and duties as applicable) by the tenderer under the rate contract should in no event exceed the lowest price at which the tenderer sells the stores of identical description to any other person during the currency of rate contract. This undertaking in writing must be submitted along with your offer (Form E-9) and in the event of price being down below the rate contract price the bidder shall promptly furnish such information to enable this office to amend the rate contract price for subsequent supplies.
31. Compliance with National/International standards if any should be specified.
32. Parallel rate contracts for similar items can be placed at any time during the period of rate contract With one or more parties.
33. After completion of one year of rate contract, Price of the item quoted will considered according to new price list submitted by bidder. It is mandatory to submit new pricelist from parent company with

- stamp and undertaking about the pricelist, failing which only old prices will be considered valid for RC.
34. The rate contract can be terminated without any notice in case the performance of the tenderer is found consistently unsatisfactory or due to the serious lapse on the part of the tenderer. Where lapses are serious nature in addition to termination of contract the firm will forfeit their Security Deposit.
  35. All disputes are subject to Gandhinagar jurisdiction only.
  36. Competent Authority, GBU reserves all the rights to accept or reject any offer in part or in full without assigning any reason/s thereof.
  37. Competent Authority, GBU reserves the right to disqualify any product which does not comply with the research standards.
  38. The tenderers will have to confirm in writing on compliance letter in their offer that all the terms and conditions mentioned above are acceptable to them.
  39. The credit bill should be presented in triplicate in the name of respective authority as quoted in final supply order is made. For any delay in payment, interest or any other kind of compensation, etc. GBU will not make extra payment.
  40. Bids shall be valid for **90 days** after the date of financial bid opening. A bid valid for shorter period shall be rejected as non-responsive.
  41. The GST charge for GBU will be 5% for the product supplied by party. GBU will provide necessary certificate along with purchase order.
  42. GBU can also ask for the test samples from dealer/manufacturer if needed.
  43. Tenderer must not be debarred or blacklisted or deregistered for the quoted item by any Government Department / Central Government / Organization / Undertaking in India at the time of opening of the tender. If any tenderer is debarred or blacklisted or deregistered during tender validity or during the validity of rate contract, by any State/Central Government / Undertaking / Organization, it is his (tenderer) responsibility to inform such thing to GBU. Failing to which will invite forfeiture of E.M.D or S.D. or Risk purchase or disqualification for appropriate period or any other penal action at discretion of GBU without any further reference.
