- 1. Gujarat Biotechnology university has conducted recruitment examinations for post of Head clerk on 17th March, 2024.
- 2. The Provisional Answer Keys and scanned OMR sheet were uploaded University website. The objections to the final answer keys were invited on university website from 17-03-2024 to 20-03-2024, 11:59PM. Accordingly, the final answer keys have been published for information of all candidates. Based on final answer keys, the marks of candidates have been published on university website for 15 days. The representation regarding final answer keys has been made by few candidates. The representation has been presented before subject expert and their opinion has been sought. The final answer keys have been reviewed by subject experts and it was opined that no changes are required in the final answer keys.
 - **Note:** In Final answer keys " X " denotes that, 1 mark will be given to all the candidates who were present in the exam.

- 6. The Reserved Category Candidates (EWS/SC/ST/SEBC), who get either equal or more than minimum marks fixed as qualifying standard for general candidates and have not availed of any relaxation in age, qualifying standard etc. at any point of the recruitment process (i.e. Meritorious reserved Category {MRC} Candidates) have been selected against unreserved posts.
- 7. In case of equal marks, the merit is assigned taking into consideration the Date of Birth (i.e. preference is given to the elder).
- 8. It has been decided to keep the number of candidates in waiting list equal to vacancy of each respective category provided minimum three candidates in waiting list for each category.
- 9. Mere inclusion of the name of the candidate in the list of provisionally eligible candidates in the result notice does not confer any right upon the candidate over the post unless the University is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 10. The provisional selection of above candidates shall be further subject to genuineness of the documents on the basis of which he/she has claimed to have fulfilled all the eligibility conditions as prescribed in the Recruitment Rules and terms and conditions of advertisement inviting applications and subject to thorough verification of his/her identity with reference to their photographs, signatures/handwriting etc. in the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by University, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other grounds for disqualifications. The decision of University regarding eligibility of the candidate shall be final and binding on the candidates.
- 11. The appointment letter to the selected candidate shall be issued within due course.
- 12. While every care has been taken in preparing result, GBU reserves the right to rectify error and omissions, if any detected at any stage.
