## Notice for Quotation for the Rental Service of Plant Growth Chamber

Sub: - Quotations are invited in sealed cover for Rental Service of Plant Growth Chamber as per duly filled in "Schedule B" (Price bid) with the following Details

1. Sealed quotations are invited for providing onsite Rental Service of Plant Growth Chamber at Gujarat Biotechnology University, Near GIFT City, Gandhinagar as Annexure-A.
2. The last date for receiving the quotation is during office hours (10:30 A.M to 6:10 P.M) up to 21/10/2024. Bidders must send the quotations via speed post/registered post/courier/register AD only. In person quotation will not be accepted. The envelope must be super scribed with the "**Quotation for the Rental Service of Plant Growth Chamber**".
3. Estimated value of the Contract Approximately Rs. 3,00,000/- (Rupees Three lakhs Only).
4. The rates quoted and agreed to by the University shall remain valid for a minimum period of 12 months which may be extended for a period of one more year on mutual consent. The decision of GBU in this regard shall be final and binding.
5. No increase will be granted during the validity of the current agreement from the date of the Contract Period.
6. Earnet Money Deposit (EMD) Details: Bidders has to submit the a 'EMD' of Rs. 10000/- (Non-interest bearing) in the form of demand draft which shall be realased to all unsuccessful bidder after completion of Bid and for successful bidder after submission of Security Deposit.
7. Security deposit (SD): The successful bidder will furnish a 'Security Deposit' of a sum of Rs.15,000/- (non-interest bearing) in the form of demand draft which shall be released only on termination of contract, after adjustment of dues, if any.

10. The Vendor shall arrange 1-2 visits during the period to ensure that the machine is working fine with minimal breakdown for GBU Gandhinagar. The Vendor shall strive to maintain the desired quality standards and ensure the smooth functioning of the instrument at all times.
11. Bidders must quote the rate for Quotation for the Rental Service of Plant Growth Chamber as per format mentioned in **ANNEXURE- B**. If any bidder fails to do the same, then bid will be rejected. The rates shall be quoted both in figures and words and should be signed by the authorized signatory.
12. The quoted rates should be for Gujarat Biotechnology University, Near GIFT City, Gandhinagar inclusive of charges viz. packing, forwarding, duties, railway freight, transit insurance etc. and free delivery at a specific location at university.
13. Statutory deductions / TDS will be levied as applicable.
14. The vendor should mention the Registration Number as required under GST, shop and Establishment Act, register of firms if any on the face of the Quotation, if the Quotation is submitted under the name of firm or partnership.
15. Bidders should have experience of similar types of work. (attach work order copies)
16. The incomplete and conditional bids will be rejected. Quoting unrealistic rates will be treated as disqualification.
17. No payment will be made in advance for any supplies under this **INQUIRY**.
18. Payment will be made after receipt of your bill in duplicate against actual work done certified by users and competent authority.
19. Net rate inclusive of all the operations started in the attached terms and conditions of the contract for the units specified in the schedule attached with the tender may be quoted. Tender not conforming to the basis of rates or units as specified in the attached sheets of conditions may not be considered even though they may be lowest, if found necessary.
20. The right is reserved to extend the time limit after the expiry of order as per requirement of university.
21. Any variation in the rates, etc. will not be allowed on any ground such as a mistake/ Misunderstanding, etc. after the quote has been submitted.
22. In case of failure on the part of the contractor to carry out the job as required, the University is at liberty without any further notices, without sending a reminder to a contractor, to get the work done on the account, at the risk and cost of the contractor and to prefer the claim for the difference in expenditure and for all the expenses whatsoever incurred in getting the unexecuted part of work completed, which the University is wholly authorized to recover from any money payable to the contractor. Such claims be adjusted from the



1. Temperature Range with lights on ( $^{\circ}\text{C}$ ): 10 - 44  $\pm$  0.5
2. Interior Space volume ( $\text{ft}^3$ ): 28.0 - 38.0
3. Total Shelving Floor Area ( $\text{ft}^2$ ): 14.0 - 28.0
4. Maximum growing height per shelf (in): 9.0 - 11.0
5. Light intensity 6" from lamps ( $\mu\text{mol}/\text{m}^2/\text{s}$ ): 120 - 200 or better
6. No. of Tiers: 3/4 or better
7. Rental period: 12 months (with possibility of extension)
