1. Gujarat Biotechnology university has conducted elimination test (OMR-based) on 15th September 2024 for the post of AE (Civil and Electrical) and ICT Officer advertised vide Advt. No: GBU/ADM/2023/01.
2. The Provisional Answer Keys and scanned OMR sheet post for which test was conducted are uploaded on the University website. The objections to the provisional answer keys were invited on university website from 15-09-2024 to 18-09-2024.

Also, the scrutiny of an applications for post of AE (Civil and Electrical), ICT Officer (only for candidates who have scored above the passing mark of 40) has been done based on the eligibility criteria as stipulated in the respective recruitment rules, terms and conditions of advertisement and correctness of the information and documents furnished/uploaded by them at the time of submission of their online application forms.

7. Please note that, list of candidates shortlisted for an interview and date of Interview will shortly be announced, candidates are advised to check university website and email regularly for an update.

Note for eligible candidates:

1. The eligibility status is **PROVISIONAL**. If at any stage it is found that any applicant does not fulfil any of the conditions of eligibility, his / her candidature will be cancelled and no appeal against such cancellation will be entertained.
2. University reserves the right not to fill any/ all posts advertised and to reject any/all application without assigning any reason.
3. **APPLICANTS MUST FULLY SATISFY ABOUT THEIR ELIGIBILITY AS PRESCRIBED IN UNIVERSITY WEBSITE AND RECRUITMENT RULES AND NOTIFICATION PUBLISHED FROM TIME TO TIME BEFORE APPEARING IN THE INTERVIEW.** If a candidate is inadvertently allowed to appear at the Interview who otherwise doesn't fulfill the minimum eligibility requirements, the candidate can't, later use that as a right to claim that candidate meets the eligibility requirements. The university reserves the right not to allow a candidate for selection if it is found that
 - a) Minimum eligibility requirements are not fulfilled.
 - b) Inadequate proof/ false documentation has been done.
 - c) Non-submission of valid NOC
 - d) Any other similar valid reasons.
