## **Provisional List of Candidates for M.Sc. Admission – Round 4 (2025-26)**

**Candidates are required to carefully read the following instructions and pay the token fee of Rs. 15,000/- online through the GBU's Admission Portal on or before 31<sup>st</sup> July 2025(11:59 PM).**

- Gujarat Biotechnology University (GBU) published the first merit list on 9th July 2025, followed by the publication of three rounds of admission.
- After the completion of all three admission rounds, a total of 111 candidates (110 + 1 EWS) paid the token fees. Subsequently, as of now, eight candidates (6 + 2 EWS) have submitted requests for cancellation of admission through official email.
- The Admission Committee has reviewed these cancellation requests and has decided to allocate these vacant seats to the next eligible candidates as per the merit list and university norms.
- The Admission Committee has decided that the number of candidates to be invited for paying the token fee and securing admission will be three times the number of seats available due to admission cancellations.
- In cases where multiple candidates have the same GAT-B score, all such candidates will be invited to pay the token fee. Admissions will be granted strictly on the basis of merit, as determined by the GAT-B score.
- Furthermore, if a candidate pays the token fee but is unable to secure admission due to their merit position or seat unavailability, the token fee will be refunded within 7 to 10 working days after the completion of the admission process.

**Note:** All the applicants paying the security deposit are hereby instructed that merely paying the security deposit won't entitle them to secure admission at GBU if the seats are not vacant and they are not in higher merit. No litigation in this regard shall be entertained by the University.

- All candidates who do not hold Gujarat domicile are considered under the General Category, irrespective of their category.
- In the event of a tie in GAT-B marks, Gujarat Biotechnology University will consider the date of birth of the candidates. The candidate who is older in age (i.e., with an earlier date of birth) will be given first preference, followed by others in the same order of age among all candidates having the same GAT-B score. No claims, objections, or legal challenges shall be entertained with respect to this criterion.
- As per the merit list, the following applicants are invited for the fourth round of admission and are required to pay a token fee of Rs. 15,000/- to secure their admission. The payment must be made through the GBU's Admission Portal on or before 31<sup>st</sup> July 2025 (11:59 PM).
- The candidates who have paid the token fee on or before 31st July 2025 and confirmed their admission are required to pay the full academic fees on or before 5th August 2025, as per the earlier notification No. GBU/ADM/Admission/243/2025-26/619 dated 25/07/2025. Candidates who fail to pay the token fee and/or academic fees by the respective due dates will have their admission cancelled, and the vacant seat will be offered to the next eligible candidate as per the merit list.
- A step-by-step guide for paying the token fee through GBU's Admission Portal has been uploaded on the university website for the convenience of applicants.

- This admission is provisional and subject to final verification of original documents during physical reporting at GBU. If a candidate fails to produce the required original documents at the time of physical reporting, the admission will be cancelled without any further notice.
