

NOTICE FOR ANTI-RAGGING

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. gg7/2009, in exercise of the powers conferred by clause (g) of sub-section (1") of section 26 of the University Grants Commission Act, 1956, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009". The Regulations are available on the UGC website i.e. www.ugc.ac.in & www.antiragging.in.

It is once again brought to the notice of all that ragging is a criminal offence and UGC has framed regulations on curbing the menace of ragging in higher educational institutions in order to prohibit, prevent and eliminate the scourge of ragging. These regulations are mandatory and all institutions are required to take necessary steps for its implementation including the monitoring mechanism. Any violation of these regulations will be viewed seriously. If any institution fails to take adequate steps to prevent ragging or does not act in accordance with these Regulations or fails to punish perpetrators of incidents of ragging suitably, it will attract punitive action against itself by the UGC.

Anti-Ragging Undertaking – Mandatory Compliance

As per the directions of the Hon'ble Supreme Court of India and the UGC Regulations on Curbing the Menace of Ragging, it is mandatory for all students to submit the Anti-Ragging Undertaking every academic year. All students are required to complete the Anti-Ragging Undertaking by following the instructions given below.

Step-by-Step Instructions for Students

1. Visit the official Anti-Ragging website

2. Submission & Reference Number

- After successful submission, you will receive a **Reference Number** on the screen and via email. This reference number can be used to **download your Anti-Ragging Undertaking**.

Important Guidelines While Filling the Form

- If your **parent/guardian does not have a mobile number or email ID**, you may provide the contact details of a **relative, friend, or neighbour**.
- Both **Student and Parent/Guardian Anti-Ragging Undertakings** are generated through the same process.

After Submission

- The student will receive an **email containing the registration/reference number**.
- The student must **forward this email to the Nodal Officer email ID** as instructed.
- **No PDF copy is sent by default, and printing or signing is NOT required**, as per the current online process.
