- 1) Online application form can be filled using the portal: <https://gbu.edu.in/career/>. The number of posts, essential qualifications, experiences, general terms and conditions etc. can be downloaded from the University website <https://gbu.edu.in/career/>
- 2) Submit three (1 Original + 2 Photocopies) hardcopies of online filled application form, with self-attested copies of certificates in support of your qualifications, experience, age, publication and all other claims made by you in a proper sequence of enclosures with numbering should reach to "THE REGISTRAR, GUJARAT BIOTECHNOLOGY UNIVERSITY, GIFT-CITY, Gandhinagar on or before 07/09/2026 up to 18:10 pm. Only online application will not be considered.
- 3) The Last Date to submit Online Applications is **31/08/2025, 23:59 pm**.
- 4) Applicants are advised to submit the applications to the University well in advance without waiting for the last date to avoid postal delay or any delay due to other unforeseen events or circumstances. The University will not be responsible for any postal delay or any delay at any stage. Applications received after the last date and time mentioned above will be rejected.
- 5) A person with benchmark disability (PwBD), having a specified disability of not less than 40% as certified by the competent medical authority in accordance with the Rights of Persons with Disabilities Act, 2016 and applicable rules/instructions of the Government of Gujarat, shall be eligible to avail the benefit of reservation.
- 6) Only Persons with Benchmark Disabilities (PwBD), having a specified disability of 40% or more, as certified by the competent authority in accordance with the RPwD Act, 2016 and applicable Government of Gujarat rules/instructions, shall be eligible to claim reservation under this Special Recruitment Drive.
- 7) Candidates claiming reservation under the PwBD category shall submit a valid Disability Certificate/Unique Disability Identity Card (UDID), wherever applicable, issued by the competent authority in accordance with the RPwD Act, 2016, applicable rules and instructions of the Government of Gujarat.
- 8) Reservation for Persons with Disabilities will be as per the existing policy of Government of Gujarat, Department of Social Justice and Empowerment and its amendments from time to time till the last date of receiving application.
- 9) PwBD candidates requiring reasonable accommodation during the interview/selection process may indicate their requirement in the application form so that necessary arrangements can be made by the University.
- 10) The University shall provide reasonable accommodation and appropriate accessibility support to eligible candidates with benchmark disabilities during the recruitment/selection process, in accordance with the RPwD Act, 2016 and applicable Government instructions.
- 11) Applicants who are already **in service** should forward printed copy of online filled application form (hard copy) **through proper channel**. Direct application will not be considered. However, such a candidate can send in advance, one copy of online application form, so as to reach before

the deadline. Such an application will be deemed in time, provided the hard copy of application through proper channel is forwarded before last date.

If the original application through proper channel has not been received by the University till the last date mentioned in this employment notification, the applicants will have to submit a '**NO OBJECTION CERTIFICATE**' from his/her employer to the University at the time of interview.

- 12) The candidates must fulfil all eligibility conditions as of the last date of receiving the application.
- 13) The reservations/relaxations policy for SC/ST/SEBC/EWS/PwBD Candidates will be provided as per the existing Govt. of Gujarat rule, and subsequent amendments from time to time till the last date of receiving application.
- 14) S.E.B.C. candidate should furnish the "**Non-Creamy-layer certificate**" valid for the current financial year of their parents in the prescribed Performa along with his/her application form.
- 15) Candidate belonging to SC/ST/SEBC/EWS/ PwBD category should submit prescribed certificate as per the Performa of State Government and Norms, failing which the candidate will not be entitled to get the benefit of reserved category.
- 16) Applicant should also submit a self-attested photocopy of any Government issued proof of Identity.
- 17) If a Candidate holds foreign University degree, he/she shall produce an equivalence certificate Page 6 of 10 issued by AIU (Association of Indian University) at the time of application.
- 18) A candidate who provides incorrect or false information or suppresses information will be disqualified and, if appointed, will be liable to be dismissed.
